

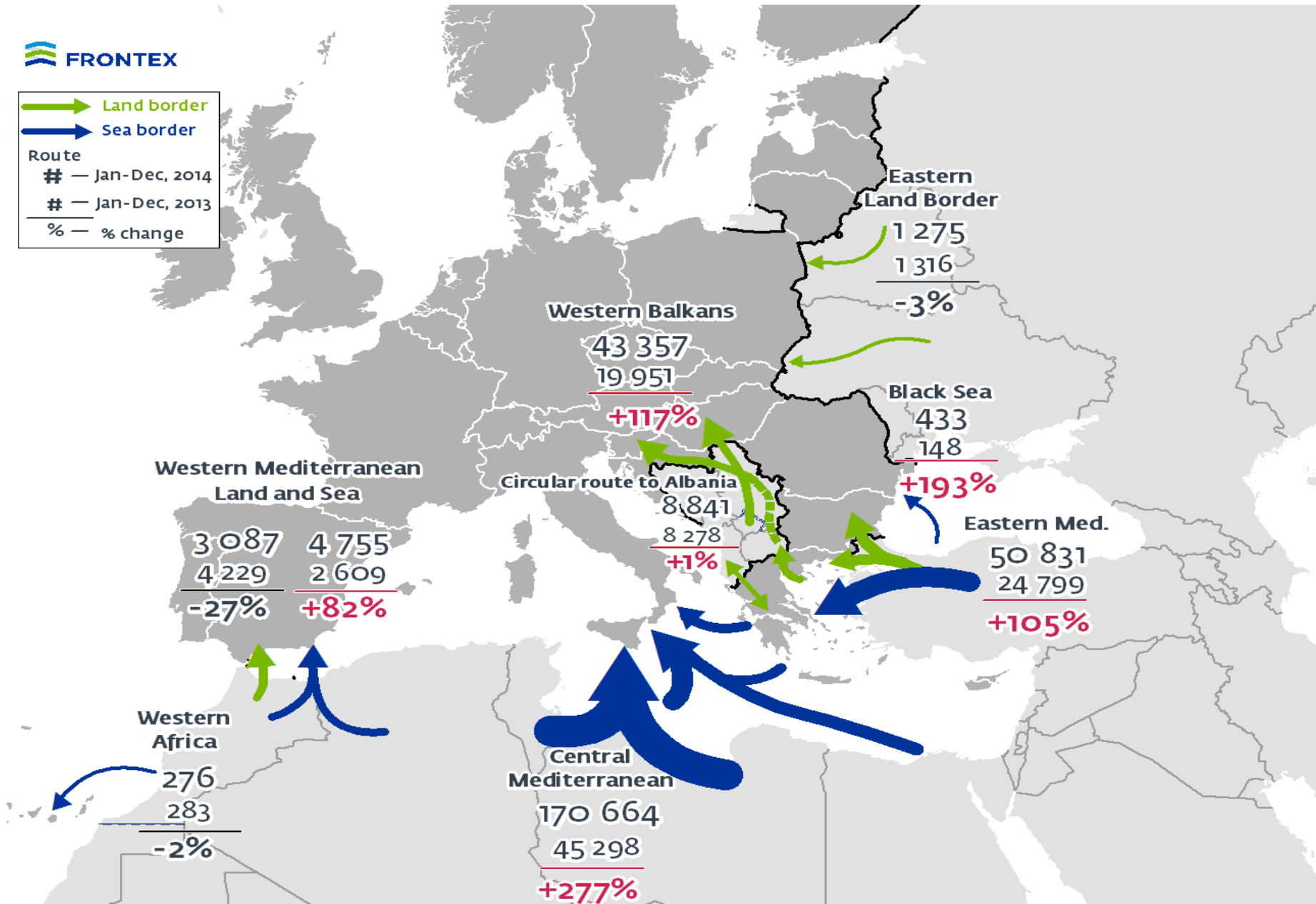


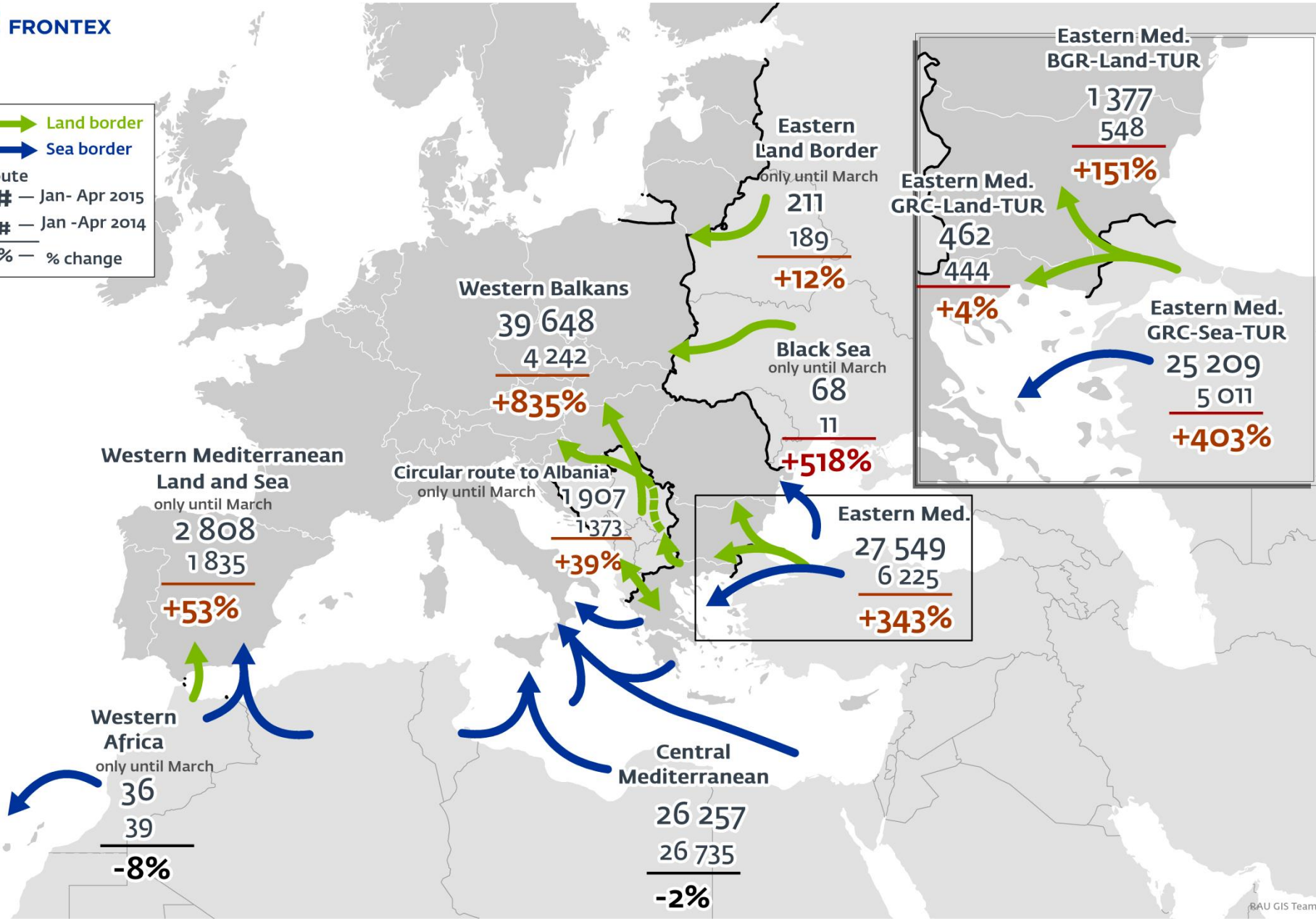
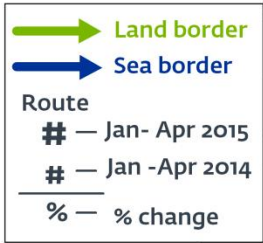

- (4) Reinforcing international solidarity and responsibility

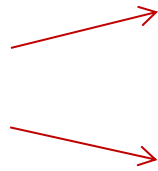
EU response

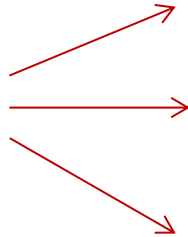

- Working better together on security
- Strengthening the pillars of the EU Action
- Three priorities:
 - i. Terrorism and Radicalisation
 - ii. Disrupting organised crime
 - iii. Fighting cybercrime

Priority areas for the Action Plan

- i. Enhanced police and judicial response
- ii. Improved gathering and sharing of information
- iii. Enhanced prevention of smuggling and assistance to vulnerable migrants
- iiii. Stronger cooperation with third countries

i. Enhanced police and judicial response

- **Identifying, capturing and disposing vessels**

Action: Establishment of list of suspicious vessels and monitoring the vessels

- **Depriving smugglers of their profits**

Action: Launching cooperation with financial institutions to step up financial investigations

ii. Gathering and sharing of information

- **Enhancing information gathering and exchange in third countries**

Action: Deployment of European Immigration liaison officers in key EU delegations

- **Monitoring of internet content and development of knowledge-base**

Action: Strengthening of JOT MARE as EU information hub on migrant smuggling

iii. Prevention of smuggling and assistance to vulnerable migrants

- **Helping business operators prevent smuggling**

Action: Development of handbook on prevention on migrant smuggling

- **Assistance to vulnerable migrants**

Action: Possible revision of EU Directive 2004/81/EC on residence permits

iii. Stronger cooperation with third countries

- **Providing capacity building in third countries**

Action: Supporting third countries to set up strategies on migrant smuggling

- **Increasing coherence and impact of EU action in third countries**

Action: Setting up of EU cooperation platforms on migrant smuggling in relevant third countries and regions
