Documentary directed by Fernand Melgar
(2011, 100 min, French version w/ English subtitles)

After "La Forteresse", which described the reception conditions of
asylum seekers in Switzerland, Fernand Melgar now looks at the
end of the migratory path. In the administrative detention facility
Frambois, detained men are waiting to be removed from the Swiss
territory. Their asylum application has failed and therefore they
are summoned to leave the country, after several years of living,
working and paying taxes and founding a family in Switzerland. If
detention can last up to 18 months, removal orders are carried
out imminently. Behind this closed doors, tension grows day by
day until the physical removal is carried out. Those who refuse to
leave will be handcuffed, bound and put in a plane. In this extreme
situation, despair has a name: special flight.
